General Information

This section reviews how to access information that is used for Customs reporting for Great Lakes Gas Transmission Limited Partnership.

Each month, GLGT reports to U.S Customs and Border Protection the volume of gas imported from Canada at Emerson and exported to Canada at Emerson, St Clair, and Sault Ste Marie. This information is provided to them at the entity level in dekatherm and M3 units.

In TC PLUS, you may access this information at the contract level for your entity.

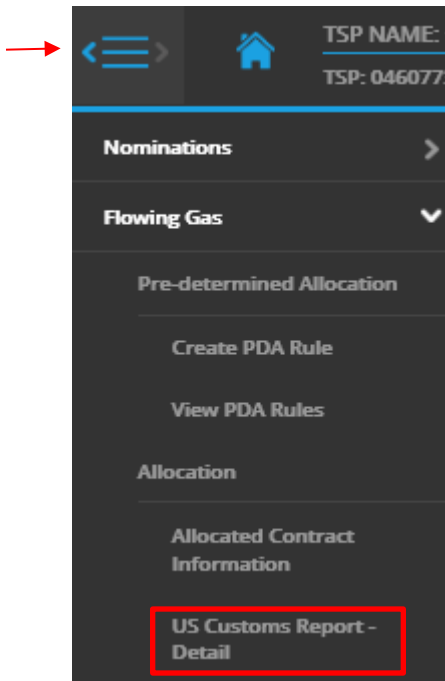
This data is available by the end of the 3rd workday following the month of gas flow.



Customs Report Detail

The US Customs Report Detail is the link to view the information reported to U.S. Customs and Border Protection each month.

From the MENU screen click on Flowing Gas and then on US Customs Report - Detail.

The Month/Year will default to the latest period for which volumes have been finalized. You may select another period to see an earlier month's detail (as more months are processed in TC PLUS).

Select the Location Name you wish to retrieve.

The Entity will default to your business name.

Delivery locations will default to Export and Receipt locations will default to Import.

Click on the Retrieve button and your data for the period will appear.
